(B) Academic Eligibility UG Courses

1. B.Sc. Nursing. BSc MLT, BCVT, BSc Perfusion Technology

1.1 Should have passed Higher Secondary examination conducted by Board of Higher Secondary Education, Kerala, or examination equivalent thereto as approved by Kerala University of Health Sciences, Thrissur. Should have separate minimum pass mark for Physics Chemistry and Biology and 50%marks in Physics, Chemistry, and Biology put together.

1.2 Eligibility Certificates: Candidates who have passed their qualifying examination from Schools/Boards outside Kerala State shall produce the certificate of recognition i.e Eligibility Certificate from KUHS Thrissur. This should be furnished at the time of interview for admission

(C) Academic Eligibility Post Graduate Degree Courses:

2. Master of Hospital Administration (MHA):

2.1 As per the KUHS admission criteria, pass in any full-time regular degree with 50% marks from UGC recognized university.

2.2 Eligibility Certificates: Candidates who have passed their qualifying examination from University outside Kerala University of Health Sciences shall produce the certificate of recognition i.e "Eligibility Certificate" from KUHS Thrissur. This should be furnished at the time of interview for admission.

3. MSc Nursing (all Specialities):

3.1) Candidates who have passed regular BSc Nursing course with minimum 55%aggregate of any University in Kerala or any other University recognized as equivalent to it by Kerala University of Health Sciences.

3.2) B.Sc. Nursing candidates should have one year experience/internship after registration with Nursing Council .

- 3.3) Post Basic BSc. Nursing qualified candidates shall have one year experience prior or after Post Basic BSc Nursing and registration in the respective State Nursing Council
- 3.4) Candidates should have valid registration from Kerala Nurses & Midwives Council (KNMC). Those candidates who have registration with other State Council should produce KNMC registration at the time of admission.
- 3.5) Eligibility Certificates: Candidates who have passed their qualifying examination from University other than Kerala university of Health Sciences shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

4. MSc MLT (all Specialties) :

- 4.1 Candidates, who have passed the B.Sc. (MLT) Degree from any of the Universities in Kerala or from any other University recognized by Kerala University of Health Sciences with a minimum of 55% marks for all the years of B.Sc. (MLT) Examination taken together, will be eligible for admission
- 4.2 Eligibility Certificates: Candidates who have passed their qualifying examination from University other than Kerala university of Health Sciences shall produce the certificate of recognition i,e "Eligibility Certificate" from KUHS Thrissur. This should be furnished at the time of interview for admission.

CENTRALISED APPLICATION AND ALLOTMENT PROCESS

(D). How to apply

Application fee:PG and UG: Rs. 1000/-

- 1.1 The application should be submitted online through the website of Aster MIMS Academy <https://astermimsacademy.com>
- 1.2 Application for each programme (PG, UG,) shall be submitted independently with prescribed links paying the *stipulated application fee separately* for each programme
- 1.3 create a login id and password by registering on the website
- 1.4 Fill up the required personal details of the candidate . (Candidates seeking admission through NRI Quota Should check appropriate tick box)
- 1.5 Upload the following documents.
 - Recent passport size colour photographs taken in a white / light coloured back ground. The image should be in JPEG format. Maximum size for photograph 50 KB and image dimension is 120x 150 px (4.23x 5.29 cm)
 - Qualifying Examination Mark list and Degree Certificates where applicable
 - Signature of the candidate
- 1.6 Pay the prescribed fee by online payment
- 1.7 A formal receipt will be issued to your email address after payment.
- 1.8 Submit the application and generate a PDF copy of the application. (No need to send the hard copy to our office)
- 1.9 No opportunity will be given to incorporate any details or documents after the closing date of the application. Late and incomplete applications will be rejected.

(E) Preparation of Merit List

1. The eligible candidates will be intimated for an aptitude test and a selection interview by the institution
2. Out of 50% management seats 35% seats will be filled by management from among the applications received and on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria and Marks scored in aptitude test.
- (3) Out of 50% management seats (15% of total seats) NRI seats shall be filled up from qualified students as per G.O (MS) No.243/2014/HRFWD dated 6.08.2014 of Govt. of Kerala. "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife /Brothers and Sisters (inclusive of first

cousins) of Father or Mother / Half Brother / Half Sister /Adopted Father or Adopted Mother who is working abroad” will only be eligible to apply in the NRI category seats”

(4) Procedure for Normalisation: The marks scored by the candidates in Physics, Chemistry, Biology and English in the Qualifying Examination conducted by various Boards will be made comparable with the marks obtained by the students in the same subjects in the qualifying examination conducted by the Directorate of Higher Secondary Examination, Kerala. Accordingly a maximum of 5 % weightage will be given to the candidates qualified from CBSE and ICSE Boards.

(5) Resolving of tie while ranking: In case of a tie in the total marks computed for ranking, candidates with higher marks obtained in English (Plus two) will be placed higher in the ranking. If the tie still exists, the candidate with higher marks obtained in Biology (Plus two) will be placed higher in the ranking. If the tie still exists, the candidate with higher marks obtained in Chemistry (Plus two) will be placed higher in the ranking. If the tie still exists, the candidate with higher marks obtained in Physics (Plus two) will be placed higher in the ranking , If the tie still exists, the percentage of total marks for plus one and plus two together in the core subjects will be considered for breaking the tie. Even after this, if tie remains, the age of the candidate will be taken into account and the older will be placed higher in ranking than the younger. If the tie still persists, tie will be resolved by a criteria as decided by the Dean/Principal/Head of the institution .

(F) Publication of Rank List.

- (1) Separate Rank Lists of each courses will be published on the website <https://astermimsacademy.com> on the date mentioned in the admission schedule furnished in the last page of this prospectus.
- (2) Validity of the Rank lists:-
 - a) The Rank lists for B.Sc Nursing course will be valid upto the cut-off date prescribed by the Indian Nursing Council.
 - b) The Rank lists for Para Medical courses will be valid upto the cut-off date prescribed by the order of Government of Kerala /Kerala University of Health Sciences.

(G) ALLOTMENTS

- (1) There will be three online allotments as mentioned in the admission schedule
- (2) The allotted candidates have to join the programme after the selection interview /verification of documents within 3 days of selection intimation after paying the full fees for the programme. The admission of those students who do not take admission within the joining date will deem to be cancelled.
- (3) For those who have selected after selection interview and not paid the college fee within the prescribed date, the admission will be summarily cancelled and seat will be allotted to the next eligible candidate. No further claim for admission will be entertained.
- (4) Spot Allotment: Spot allotment will be conducted based on the vacant seats including Government lapsed seats available in the institutions. However the date and place of spot allotment will be duly intimated through our website and leading newspapers after obtaining permission from AFRC.

(H) Selection and Verification of Documents:

- (1) The Selected candidates will be intimated for a selection interview by the institution. The Principal/Head of the College or Institution shall be personally responsible for verification of original documents and satisfaction of the correctness of the records produced by the candidate.
- (2) Any mismatch in the marks and any other false information recorded in order to gain admission will be summarily rejected.

“In addition to the above , all the selected students should produce a character certificate from the institute (Principal or HOD or Class coordinator) where from he / she has passed the qualifying Examination, which would mention the status of his / her behavioural pattern especially in terms as to whether he / she has displayed persistent violent, or aggressive behaviour or any desire to harm others.”

(I) General Information

1. The medium of instruction and examination shall be in English
2. For B.Sc. Nursing course, hostel accommodation is mandatory for female students.
3. All PG and Degree programs are affiliated to Kerala University of Health Sciences (KUHS)
4. Use of Mobile Phone by students is not permitted in the campus, hospital and hostels. Any violation of this prohibition will lead to stringent disciplinary action by the college authorities. However, students can use mobile phones at the allotted time /day while in the hostel.
5. Every student is required to adhere strictly to the code of conduct of the institution.

7. Any other items not specifically covered in this prospectus will be decided by the undersigned, and his decision shall be final.

(J) Special Instruction:-

- (1) **Course Discontinuation/ Liquidated damage**
If any candidate discontinues the course after the cut of date of admissions as notified by the KUHS/Competent authority, the candidate has to follow the instruction/ clause given in the Govt Prospectus on Liquidated damage to collect the certificates and TC from the institution.

(K) Prohibition of Ragging:

1. According to the Kerala Prohibition of Ragging Act, 1998, 'ragging' means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to that student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such student will not in the ordinary course be willing to do.
2. Ragging / any type of misconduct towards any student either in the College campus or outside will be considered as criminal offence and will be immediately reported to the police. Perpetrators will not be permitted to continue their studies.
3. Students and parents shall, at the time of admission, furnish an affidavit in the appended format to the effect that the students will not implicate in ragging.
